"Many times, the weather wasn't safe for travel," says her daughter, Cindy, "but, she knew that families depended on her and so she would get in her car and venture out." Her presence was felt by everyone waiting anxiously for news about their loved ones. Families were always grateful for her friendly, caring and compassionate ways. Many times, she would stay past her volunteer shift.

Earlier this year, Rose passed away at the age of 91. To recognize both of their parents, the family decided to contribute to the St. Alexius Tree of Life. "We chose to contribute to the Tree of Life, recognizing the importance of the future of St. Alexius." In June, Cindy along with her sisters LaVerne, Judy and Sandy, contacted the St. Alexius Foundation. They presented a check and chose the leaf that will be inscribed *Rose K. and Jack Y. Leingang*.

The St. Alexius Foundation dedicated the Tree of Life in 1988. Located in the south entrance lobby of

the medical center, the Tree of Life was designed as a permanent tribute to those who have been very generous to St. Alexius Medical Center. The Tree of Life honors and remembers families and friends by having the name or names of your choice permanently engraved on a golden leaf or golden stone on the Tree of Life.
